## **Victoria Quarter Planning Application** (23/3964/FUL)

Following the public exhibition staged by Fairview New Homes and One Housing in July, a planning application for the old New Barnet Gasworks site has now been submitted to Barnet Council. LINK: tinyurl.com/vqsept2023

"Construction of a residential-led, mixed use development to provide 420no. residential units (Use Class C3) and 279.2sqm of commercial space (Class E) across 11no. buildings ranging from 4 to 8 storeys in height, and basement level. New public realm with communal landscaped amenity areas, creation of new pedestrian routes, 295no. car parking spaces, including car club and accessible provision, secure cycle parking, servicing and other associated development."

The deadline for the public to comment on the plans is **Friday 3 November 2023**. LINK: www.barnet.gov.uk select 'Planning & Building' and enter the reference **23/3964/FUL** in the search function

Construction of the first two blocks on the site (H & J) fronting Victoria Road is now underway after plans were approved earlier this year. This new planning application is for the remainder of the already cleared site. Adding the 420 flats in these new proposals to the 66 under construction will bring the site total to 486.

You will recall that there are approved plans for 371 homes on the site, in what is known as the 2017 Combined Consented Scheme, but this has not been built.
